WHY TAKE THE RISK?

If you leave your current employer any benefits provided to you by your employer will cease. This means that, unless you have insurance elsewhere, you and your family will not be protected in the event of your death, disability or illness. Your financial future could be at risk!

Retain your insurance via the continuation option

A continuation option allows you to transfer the group insurance to a policy of your own without having to complete extensive paperwork or having to provide detailed evidence of your current health. This simple process allows you to continue the insurance you have received from your employer.

Your employer's policy may provide you with an opportunity to purchase your own insurance for:

- Life insurance; and/or
- Total & Permanent Disability; and/or
- Income Protection and/or Trauma insurance; and/or
- Medical insurance

Act promptly

The continuation option is only available for a short period after you leave your current employer. Generally, this period is only 30 days.

The information required overleaf must be received by Marsh within the availability period in order to allow us to advise the insurer. If this period has expired, a continuation option will no longer be available. So the time to act is now!
