A continuation option allows you to transfer your employer benefit insurance to a policy of your own without having to complete extensive paperwork, or having to provide detailed evidence of your current health. When leaving employment, your employer's policy may provide you with an opportunity to purchase your own insurance for:


- Life insurance; and/or
- Total & Permanent Disability; and/or
- Income Protection and/or Critical Illness insurance; and/or
- Medical insurance

Act promptly

The continuation option is only available for a short period of time after you leave your current employer. This period can vary from 30 to 60 days depending on the insurer.

The information required overleaf must be received by Mercer Marsh Benefits™ within the availability period in order to allow us to advise the insurer. If this period has expired, a continuation option will no longer be available.
